Marriage could not be free if the Law has put the onus of mutual. from which, as a matter of course, a real husband and real wife may be separated at any time by mutual consent even if one of them has a husband or wife not according to the Law.. A Hindu person, whether a male or female can be married to more than one wife or husband. The only right of a Hindu husband or wife to choose their own wife or husband is not free. A Hindu husband or wife cannot freely select their wife or husband at his or her own will. This alienation of the husband, who is the male. spouse cannot be voluntary. Hence it is an act of a constrained person. This alienation of the husband, or an act of an act of free will in a matter of great importance is not justifiable under the Hindu Law. 3.
